
Sue Altman Has Publicly Supported Legislation To Decriminalize All Drugs, Including Crack, Heroin, And Fentanyl

In June 2021, Altman Criticized A Legislator Who Expressed Concern Over A Bill That Aimed At Decriminalizing All Drugs, Including Cocaine, Heroin And Fentanyl

In 2021, Reps. Bonnie Watson Coleman And Cory Bush Introduced The Drug Policy And Reform Act, Which Aimed To "Decriminalize All Drugs, Expunge Existing Records And Allow For Re-Sentencing …" And Other Items. "FIFTY YEARS AGO on Thursday, President Nixon declared a 'War on Drugs.' In a special address to Congress, he promised a coordinated federal response to drug addiction, which he described as a 'national emergency' that 'destroys lives, destroys families, and destroys communities.' Five decades and hundreds of billions of dollars later, the War on Drugs has done nothing to curb addiction. Instead, it has destroyed the lives, families, and communities of millions of Americans, disproportionately people of color, who have been incarcerated for drug offenses. Reps. Cori Bush (D-Mo.) and Bonnie Watson Coleman (D-N.J.) are attempting to undo some of this damage by introducing the Drug Policy Reform Act. The DPRA, which the two lawmakers are introducing Tuesday, would decriminalize all drugs, expunge existing records and allow for re-sentencing, and invest in health-centered measures to take on drug addiction. The bill has little chance of passing through Congress, but it will serve as an important legislative marker for the movement to end the punitive War on Drugs." 

"Section 5: Eliminates Criminal Penalties for Personal Use Possession • Eliminates criminal penalties for personal use possession of all scheduled drugs (marijuana, heroin, crack/cocaine, etc.). • Individuals may still be fined for drug possession, but the court may waive this fine if it determines that an individual cannot pay. • Eliminates eligibility for Byrne or COPS grant programs for states and localities that maintain criminalization of personal use drug possession." Altman Supported Legalizing Recreational Marijuana

In February 2021, Gov. Phil Murphy Signed Legislation To Legalize Recreational Marijuana For People 21 And Older. "New Jersey Gov. Phil Murphy on Monday signed bills to legalize and regulate marijuana use for those 21 and older, decriminalize possession of limited amounts of marijuana and clarify marijuana and cannabis use and possession penalties for those younger than 21. 'This legislation will establish an industry that brings equity and economic opportunity to our communities, while establishing minimum standards for safe products and allowing law enforcement to focus their resources on real public safety matters,' Murphy, a Democrat, said in a news release, thanking legislative and community partners for their work on the issue. 'Today, we're taking a monumental step forward to reduce racial disparities in our criminal justice system, while building a promising new industry and standing on the right side of history.'" In 2020, Our Revolution New Jersey Circulated A Petition Calling For State Lawmakers To Pass Legislation To Release All Prisoners Held On Cannabis Related Offenses, And For All Cannabis-Related Crimes To Be Expunged From Criminal Records. 
