



Maine Lobstermen Were Eligible For Up To \$50 Million In Economic Relief. "Maine lobster fishermen are about to get a \$50 million federal bailout to offset the crippling impact of the United States-China trade war. The U.S. Department of Agriculture announced on Wednesday the creation of a \$527 million seafood trade relief program that will pay licensed fishermen a species-specific amount for every pound landed in 2019 to absorb sales declines and increased marketing costs caused by China's retaliatory tariffs. <u>In 2021, NOAA Introduced Crippling Regulations On The American Lobstering Industry That Have Led Some In The Industry To Quit Following The New Regulations Taking Effect In 2024</u>

On August 31st, 2021, NOAA Announced New Regulations On North Atlantic Fisheries, Including The Lobstering Industry, In The Name Of Conservation Efforts To Save The North Atlantic Right Whale. "Today, NOAA Fisheries announced new regulations for the lobster and Jonah crab trap and pot fisheries operating in the Northeast United States to help save endangered North Atlantic right whales by reducing their risk of entanglement in fishing gear. NOAA Fisheries and our partners are dedicated to conserving and rebuilding the North Atlantic right whale population, which is endangered and declining. The decline began in 2010, and accelerated most notably when 17 mortalities were documented in 2017, leading to the declaration of an ongoing Unusual Mortality Event. Since then, 34 right whales have died and 16 have been seriously injured, primarily due to entanglements and vessel strikes." The NOAA Lobstering Regulations, Which Went Into Effect In 2024, Were Described As "So Strict, They Could Put Them Out Of Business." "The price of lobsters at the docks has ebbed and flowed in recent years, but it has stayed fairly consistent to consumers. The price at the docks spiked to more than \$6.70 per pound in 2021 and fell to less than \$4 per pound in 2022. Last year, it was a little less than \$5 per pound, and the total catch was worth more than \$460 million at the docks, according to data released Friday. That is the third highest figure of the last four years. The state's fishermen have been in a lengthy legal battle with the federal government over rules designed to protect the whales, which are vulnerable to entanglement in fishing gear. The fishermen argue the proposed rules are so strict they could put them out of business, but conservationists say they are essential to save the whales, which number less than 360 in the world. A right whale found dead off Massachusetts this winter showed signs of entanglement in Maine gear." "For necessary expenses of activities authorized by law for the National Oceanic and Atmospheric Administration, including maintenance, operation, and hire of aircraft and vessels; pilot programs for State-led fisheries management, notwithstanding any other provision of law; grants, contracts, or other payments to nonprofit organizations for the purposes of conducting activities pursuant to cooperative agreements; and relocation of facilities, \$4,157,311,000, to remain available until September 30, 2023: Provided, That fees and donations received by the National Ocean Service for the management of national marine sanctuaries may be retained and used for the salaries and expenses associated with those activities, notwithstanding section 3302 of title 31, United States Code: Provided further, That in addition, \$243,532,000 shall be derived by transfer from the fund entitled "Promote and Develop Fishery Products and Research Pertaining to American Fisheries", which shall only be used for fishery activities related to the Saltonstall-Kennedy Grant Program; Fisheries Data Collections, Surveys, and Assessments; Observers and Training; Fisheries Management Programs and Services; and Interjurisdictional Fisheries Grants: Provided further, That not to exceed \$67,867,000 shall be for payment to the "Department of Commerce Working Capital Fund": Provided further, That of the \$4,423,843,000 provided for in direct obligations under this heading, \$4,157,311,000 is appropriated from the general fund, \$243,532,000 is provided by transfer, and \$23,000,000 is derived from recoveries of prior year obligations."
