Deadly Drugs

In 2024, Record Amounts Of Dangerous Drugs Like Methamphetamines And Fentanyl Were Seized By United States Law Enforcement

Seizures Of Fentanyl Are Up 480 Percent At The Southern Border In Fiscal Year 2023 Compared To Fiscal Year 2020. “Data indicates drug seizures at the U.S.-Mexico border, by pounds seized, are trending down. The good news, at closer look, can be misleading. Seizures of heavier, less-potent drugs like marijuana are down while illicit fentanyl, a drug 100 times more potent than morphine, are up significantly: 480 percent higher at the southern border in fiscal year (FY) 2023 compared to FY 2020.” (Christian Penichet-Paul, “Illicit Fentanyl And Drug Smuggling At The U.S.-Mexico Border: An Overview,” [National Immigration Forum](#), 10/25/23)

On May 9, 2024, McDonald Rivet Voted Against Deploying The National

Guard To The Southern Border. “Senate Bill No. 762, entitled A bill to make appropriations for the department of military and veterans affairs for the fiscal year ending September 30, 2025; and to provide for the expenditure of the appropriations. The question being on the passage of the bill, Senator Nesbitt offered the following amendments: 1. Amend page 5, after line 11, by inserting: “National Guard deployment to southern border 8,000,000”. 2. Amend page 5, line 15, by striking out “21,000,000” and inserting “29,000,000.” 3. Amend page 5, line 18, by striking out “21,000,000” and inserting “29,000,000” and adjusting the subtotals, totals, and section 201 accordingly. The question being on the adoption of the amendments, Senator Lauwers requested the yeas and nays. The yeas and nays were ordered, 1/5 of the members present voting therefor. Senate Bill 725 Would Have Prohibited Counties From Establishing Sanctuary Policies.

“A bill to prohibit municipalities from imposing a ban on the use of natural gas or the installation of natural gas infrastructure; to provide for the powers and duties of certain local governmental officers and entities; and to provide that certain local ordinances, resolutions, or policies are void and unenforceable.” (Senate Bill 725, [Michigan Legislature](#), Accessed 8/6/24)

Supported Providing Taxpayer-Funded Lawyers For Illegal Immigrants

On May 14, 2024, McDonald Rivet Voted Against An Amendment That Would Prohibited Illegal Immigrants From Receiving Taxpayer-Funder Lawyers. “Senator Hauck offered the following amendment: 1. Amend page 27, following line 21, by inserting: ‘Sec. 310. Funds appropriated under part 1 must not be used to provide legal assistance to individuals who do not have a documented legal status.’. Voted Against Increasing Punishments For Fentanyl Distribution

On February 28, 2024, McDonald Rivet Failed To Vote For An Amendment To Block The Enforcement Of A Bill Unless Senate Bills 726 And 727 Was Enacted Into Law. “The following bill was read a third time: House Bill No. 4857, entitled A bill to amend 1941 PA 359, entitled “An act for controlling and eradicating certain noxious weeds within the state; to permit townships, villages, and cities to have a lien for expenses incurred in controlling and eradicating such weeds; to permit officials of counties and municipalities to appoint commissioners of noxious weeds; to define the powers, duties, and compensation of commissioners; to provide for sanctions; and to repeal certain acts and parts of acts,” by amending section 2 (MCL 247.62), as amended by 2010 PA 358. The question being on the passage of the bill, Senator Bellino offered the following amendment: 1. Amend page 2, following line 25, by inserting: ‘Enacting section 1. This amendatory act does not take effect unless all of the following bills of the 102nd Legislature are enacted into law: (a) Senate Bill No. 726. (b) Senate Bill No. 727.’ The question being on the adoption of the amendment, Senator Lauwers requested the yeas and nays.” (HB 4857, [Roll Call #38](#), Failed: 18 – 20, Rivet Not Voting, 2/28/24)
