

According To Reporting, Cooke Raised Millions Of Dollars For Liberal Congressional Candidates, Including In California. "Beginning in late 2012, Cooke, 36, served as finance director for four congressional races in Minnesota, Michigan, Colorado and California, raising \$3.7 million in one of those contests. In 2015, she registered Cooke Strategy LLC, a Democratic political and fundraising consulting firm. FEC records show the firm advised eight state and federal campaigns between 2015 and 2021. ... Between 2012 and 2014, FEC records show that Cooke did fundraising work for Democratic candidates Jim Graves of Minnesota, Joe Miklosi of Colorado and Syad Taj of Michigan, all of whom lost or withdrew from their races, and Rep. Raul Ruiz of California. Cooke said on her defunct campaign website that she helped raise \$3.7 million for Ruiz."
